Admission requirements

Program eligibility

Postsecondary diploma and/or degree with related courses. Applicants with an unrelated diploma and/or degree are required to submit documentation confirming volunteer and/or paid hours.

Applicant selection

Eligible applicants will be selected on the basis of previous academic achievement and related courses, and/or demonstrated experience.

In some cases, applicants may be required to submit confirmation and verification of volunteer/paid hours working in early learning, validated by a Registered Early Childhood Educator (RECE).

Applicants may be required to complete English testing to demonstrate proficiency.

Postsecondary transcripts, indicating courses completed to date, must be submitted to ontariocolleges.ca at the time of application.

Applicants who do not meet the admission requirements for this program may be advised individually regarding other related programs.

Criminal record check and immunization requirements

Completion of all field placements is a mandatory program requirement. Students completing field placement will be required by their field placement site to provide a current, acceptable and valid police check which includes a Vulnerable Sector Check (VSC) along with an up to date health clearance and immunization record. Many of our field placement sites are also requiring that students be fully vaccinated against COVID-19. Students must follow the COVID-19 vaccination policy of the field placement site they are attending. Students who cannot meet these requirements will have limited field placement opportunities and may be unable to progress or graduate from the program. This may also impact future career opportunities in the profession.

English language proficiency

All applicants whose first language is not English must meet Sheridan's English proficiency requirements.
