#### **CALL TO ORDER**

## APPOINTMENT OF CHAIR

The Board Chair is required to be appointed on an annual basis. With the retirement of Bryan Dawson, on February 21, 2018, there is a need to appoint a Board Chair for the remainder of this year, a term of approximately 5 and one half months, effective March 8 to August 31, 2018.

By e-mail dated March 1, a request for anyone wishing to stand for the role of Board Chair was circulated. Steve Boone has indicated his intention to stand for the position of Board Chair. No other expressions of interest were received.

Call for expressions of interest at the meeting did not yield any other Governor.

It was moved by Mr. Depascal, seconded by Mr. Fleming,

"that Mr. Steve Boone be appointed as Board Chair for a term effective March 8 to August 31 2018."

Carried.

Mr. Boone abstained from voting.

As Mr. Boone was Vice Chair, the position being vacated by Mr. Boone's appointment to Board Chair, it is necessary to appoint the position of Vice Chair for a term from March 8 to August 31, 2018. Mr. Fleming advised of his intention to stand for the position of Vice Chair. No other expressions of interest were received.

Call for expressions of interest at the meeting did not yield any other Governor.

It was moved by Ms. Heath, seconded by Ms. Rivard,

"that Mr. John Fleming be appointed as Vice Chair for a term effective March 8 to August 31 2018."

Carried.

Mr. Fleming abstained from voting.

Election of the roles of Chair and Vice Chair for 2018/19 will take place at our May 31, 2018 Board meeting.

# APPROVAL OF PRESIDENTIAL SEARCH COMMITTEE MEMBERSHIP

Upon the recommendation of the Governance Committee, the committee membership was amendment to remove Mr. Dawson given his retirement and to add Ms. Rivard to the Presidential Search Committee membership.
