Program Eligibility

In addition to studying all aspects of virtual production, in Term 2 you can specialize in one of three professional electives: technician (often referred to as a VP generalist), camera or art department. View the website for details and courses: <u>Advanced Television and Film – Virtual Production</u>.

Program eligibility:

• A post-secondary diploma or degree in film production, game design, or visual effects

or

 Two years of experience in related industries having worked on feature films or streamed/network productions evidenced through the Experience Based Admission Requirements listed below.*

Applicants selected for the program will be notified through their Sheridan email account. Decisions will not be released over the phone. Fee, registration and timetable information will follow.

Assessments will be made on a first-come, first serve basis for the remaining available seats. It's in your best interest to submit your documentation as soon as possible.

Academic Integrity

By submitting your Admission Requirements, you are agreeing to comply with Sheridan's Academic Integrity Policy. The Academic Integrity Policy states:

Sheridan College is committed to upholding the highest standards of academic integrity. The International Centre for Academic Integrity (ICAI) defines academic integrity as "a commitment, even in the face of adversity, to six fundamental values: honesty, trust, fairness, respect, responsibility, and courage. From these values flow principles of behavior that enable academic communities to translate ideals into action".

Applicants who are found to have falsified transcripts, cheated on admission tests, or submitted fraudulent documents or in any other way attempted to circumvent the admissions process in a manner inconsistent with the principles of academic integrity, will not be granted admission to the College. Those applicants will be ineligible for admission to any Sheridan program or course for a period of not less than 5 years, after which admission to the College will be reviewed on a case-by-case basis.

For programs where a portfolio submission is required as part of the admission process, portfolio work should represent an applicant's own ideas, writing, projects and creations. Where others have contributed, or non-original ideas have been included, applicants will give proper recognition and reference. Applicants are not allowed to use advanced automated tools (artificial intelligence or machine learning tools such as ChatGPT) for written or visual components of portfolio submissions.

Experience Based Admission Requirements

Submit a Statement of Intent that includes an effective narrative of why you should be in the program. It should articulate your reasons for pursuing Sheridan's Advanced Television and Film (ATVF) Program in the following ways:

- Expressing how Sheridan's ATVF Program will help you reach your personal, artistic, and career goals.
- Incorporating a description that tells us about yourself and your industry experience.
- Discuss your experience with industry-related software (visual effects/production design/gaming related), and hardware (camera/gear/consoles/accessories) that is relevant to your past experiences.

Your Statement of Intent submission must fall under ONE of the following types. There is no order of preference in this list, lengths stipulated are maximum allowable lengths. Submissions can be shorter.

- 1. Written Submission must be a maximum of 500 words (Times New Roman, 12pt font, double-spaced, in a PDF file).
- A 2-minute video Submission format must be a Vimeo or YouTube link. If the video is
 password protected, please provide the password. Put the link to the video, and password (if
 applicable), in a document and upload the PDF. Alternatively, you can submit your video
 directly into the online submission system with the "Upload Files" feature.
- 3. A 2-minute audio clip Submission format must be an MP3 file. Submit your audio clip directly into the online submission system with the "Upload Files" feature.
- 4. A slideshow Maximum of 10 slides. Submission can be a PowerPoint / Keynote slide deck, exported as a QuickTime movie, or a PDF file.

Instructions for Online Submission of your Statement of Intent

Please follow the steps below in order to submit your additional admission requirements:

- 1. **LOGIN:** You will be required to use your Sheridan username and password to enter the online submission at https://cerebro.ddi.sheridanc.on.ca/submit
- 2. **READ THE INSTRUCTIONS**: Once you login you will be required to acknowledge that you have read the instructions.
- 3. **PAYMENT**: You will be required to make a non-refundable payment of \$50.00 Canadian with a debit or credit card for your portfolio to be assessed. If you have already paid a portfolio fee for a program in the fall term, you will not be required to pay the fee again for another program in the same term.
- 4. **UPLOAD FILES**: Select "Upload Files" to remit your Statement of Intent
- 5. READ THE SPECIFICATION for each category and verify that your files are the correct file type. When you are ready to upload, drag your files into the appropriate drop zone. When the upload is complete, you will either see the files you have submitted added to your list, or a message describing the problem with the submitted file. It is your responsibility to check your own files that they have uploaded correctly. You will not be contacted if files don't open. You will receive a score of 0.
- SUBMIT FOR EVALUATION: If you are finished selecting and uploading files, you may now click "Submit for Evaluation" to notify Sheridan that your portfolio is complete and ready for grading. During the grading process, your files will be locked and unable to be changed.
