Program Information and Eligibility

Our graduate certificate program is unique in that successful graduates are eligible for THREE external accreditations:

- University of Cambridge CELTA (Certificate in English Language Teaching to Adults)
- TESL Ontario OCELT
- TESL Canada (Standard 2)

Eligible Applicants are selected on the basis of:

- Undergraduate degree from an accredited college or university. Applicants with postsecondary education from outside of Canada must submit an international credential assessment. Plus
 - English language proficiency (if English is not your mother tongue):
 - TOEFL iBT Listening: 24; Reading: 24; Writing: 27; Speaking: 27 (or equivalent) Overall: 101
 - o IELTS-Academic Listening: 7; Reading: 7; Writing: 7; Speaking: 7 Academic Overall:7

Sheridan's English language requirement (TOEFL/IELTS) is aligned with the <u>TESL Ontario</u> and <u>TESL Canada</u> accreditation requirements.

- 2. Pre-interview submission (reviewed during interview) and
- 3. An interview is a required for admission as we are an accredited Cambridge CELTA centre.

Postsecondary transcripts and English proficiency must be submitted at the time of application. Only applicants who have met the requirements in steps 1 and 2 will be invited to an in-person, telephone or online interview. Applicants will be notified by their Sheridan email account. Decisions will not be released over the phone. Fee, registration, and timetable information will follow after an applicant has accepted their offer.

Academic Integrity

By submitting your Admission Requirements, you are agreeing to comply with Sheridan's Academic Integrity Policy. The Academic Integrity Policy states:

Sheridan College is committed to upholding the highest standards of academic integrity. Applicants are not allowed to use advanced automated tools (artificial intelligence or machine learning tools such as ChatGPT) for written or visual components of portfolio submissions.

Instructions for Applicants

Steps to proceed with your application:

- 1. <u>Submit transcripts and proof of English proficiency (if English is not your mother tongue).</u>
- 2. Complete and submit the Pre-Interview questions (2)
- 3. After steps 1 and 2 are successfully completed, you will be contacted to set up an interview

1. Transcripts & English Proficiency

Submit your university/college degree transcripts, indicating all courses completed to-date. *Notes:*

- If your degree is from a non-Canadian institution, you must provide a general (document by documents) WES or ICAS educational evaluation. <u>https://www.sheridancollege.ca/admissions/how-to-apply/credential-evaluation</u>
- English proficiency requirements are listed under <u>Program Information and</u> <u>Eligibility</u> for those whose mother tongue is not English.

2. Pre-Interview Submission

Please answer the following two questions (maximum 200 words per question):

Question 1.

Why are you interested in becoming an English language teacher? **OR** If you are already an English language teacher, why are you interested in taking the TESOL Plus program?

Question 2.

Describe the best teacher you had and explain why you felt they were so effective. Consider:

- their strategies and techniques
- the atmosphere they created in the classroom
- the opportunities for interaction and pair/group work
- the materials they used
- how their strategies and techniques supported learners of a new language

3. The Interview

Once steps 1 and 2 have been successfully completed, the next step is the interview (inperson, telephone, Skype, Zoom or Webex). Our TESL Program Support Specialist will contacting applicants to set up a mutually convenient date and time for the interview.

This familiarization exercise will help you to think about language and teaching, as well as introduce you to some of the program materials.

Please come prepared to answer the following questions (you do not need to submit your answers to these questions before the interview, just be prepared to discuss them):

- 1. What is the difference in meaning between these two sentences?
 - i. I was walking to the corner when I saw my friend.
 - ii. I walked to the corner when I saw my friend.
- 2. What is the error in this sentence and why might a student make this kind of error?
 - They have four childs.
