# **Selection Process for Applicants**

Eligible applicants are selected on the basis of their previous recognized post-secondary academic achievement, demonstrated relevant experience and English language skills. Applicants with 2 years or less post-secondary studies are required to provide the information below to determine eligibility.

Postsecondary transcripts, indicating courses completed to-date, must be submitted at the time of application.

Applicants selected for the program will be notified through their Sheridan email account. Decisions will not be released over the phone. Fee, registration and timetable information will follow.

# **Academic Integrity**

By submitting your Admission Requirements, you are agreeing to comply with Sheridan's Academic Integrity Policy. The Academic Integrity Policy states:

Sheridan College is committed to upholding the highest standards of academic integrity. The International Centre for Academic Integrity (ICAI) defines academic integrity as "a commitment, even in the face of adversity, to six fundamental values: honesty, trust, fairness, respect, responsibility, and courage. From these values flow principles of behavior that enable academic communities to translate ideals into action".

Applicants who are found to have falsified transcripts, cheated on admission tests, or submitted fraudulent documents or in any other way attempted to circumvent the admissions process in a manner inconsistent with the principles of academic integrity, will not be granted admission to the College. Those applicants will be ineligible for admission to any Sheridan program or course for a period of not less than 5 years, after which admission to the College will be reviewed on a case-by-case basis.

For programs where a portfolio submission is required as part of the admission process, portfolio work should represent an applicant's own ideas, writing, projects and creations. Where others have contributed, or non-original ideas have been included, applicants will give proper recognition and reference.

# **Additional Admission Requirements**

In order to continue processing your application, you must submit a single document that includes both your <u>résumé</u> and one-page <u>cover letter</u>. The online submission system will open on **November 2024**.

#### RÉSUMÉ

Your résumé must include the following, but not be limited to:

- Academic background: Degree and/or diploma completed, duration of studies and educational institution
- Paid work and volunteer experience: Name of organization, duration of employment, roles and responsibilities, results achieved
- Project management experience (if applicable): Name of organization, project title and duration, your project roles and responsibilities, project results achieved
- For one of the project experiences that you address in your résumé, please elaborate on what responsibilities and successes you had regarding each of: project work, meeting customer requirements, teamwork on the project, and managing the other project stakeholders. Please limit this elaboration to no more than one additional page in your usual résumé.

#### **COVER LETTER**

Your cover letter (one page maximum) must describe your personal or professional goals and explain how our specific program will assist you to achieve these goals.

**NOTE**: Résumé and cover letter formats vary by country. Applicants must ensure their documents follow Canadian format and standards. You can find more information regarding how to write your résumé **here**.
